PRESENTATIONS

Two high school students, Alexander Raia and Stephen Stork were introduced by Mr. Clark. Both students have achieved the rank of Eagle Scout. Alex explained his Eagle Scout project which was to install a split rail fence at Theodore Roosevelt's gravesite, which included 32 sections of fencing. Stephen explained his Eagle Scout project which was installing benches, shrubbery around the flagpole at JFK. Both boys created a budget, raised the funds and had helpers to do the work. Bethpage Schools has had 4 students achieve the rank of Eagle Scout this year.

Mr. Tom Kenny, Guidance Director presented a Power Point presentation to the Board and community to highlight the work that the guidance department has done this past year at the High School. Activities have included a college fair, senior seminar class, college planning guides, ACT/SAT exams as well as the Naviance program that the students/parents can use.

Mr. Clark informed all that Governor Cuomo, County Executive Edward Mangano along with other politicians were here today to sign a bill to allow one speed camera to be installed in each of the school districts in Nassau and Suffolk county.

REVERSION OF MONIES FROM THE DISTRICT'S TAX CERTIORARI RESERVE FUND TO THE DISTRICT'S GENERAL FUND:

MOTION by Mr. Spears, seconded by Mr. McGlynn, WHEREAS, in 2010 the County passed Local Law 18-2010 which attempted to repeal Nassau County's hold harmless provision and require school districts to pay tax certiorari refunds commencing with tax certiorari actions filed attendant to the 2012-2013 tax roll; and

WHEREAS, as a result in May, 2013, the District established a Tax Certiorari Reserve Fund ("TCRF") and in June, 2013, funded the reserve in the amount of \$1,300,000 in anticipation of the need to pay judgments and claims arising out of such tax certiorari proceedings (the District did not place any additional monies into a TCRF during the 2013-2014 school year); and

WHEREAS, a legal challenge was made to the validity of Local Law No. 18-2010 and in February, 2014 the State's highest court, the Court of Appeals, upheld the Appellate Division's finding that Local Law No. 18-2010 was invalid and, thus, the County's obligation to hold school districts harmless for assessment errors remained intact; and

WHEREAS, pursuant to Education Law §3651 which governs tax certiorari reserve funds, monies "which will not reasonably be required to pay any such judgment or claim shall be returned to the general fund on or before the first day of the fourth fiscal year following the deposit of such monies to said reserve fund."; and

WHEREAS, for purposes of Education Law §3651, monies "shall be deemed reasonably required to pay any such judgment or claim if the proceeding or claim has not been finally determined or otherwise terminated or disposed of after the exhaustion of all appeals."; and

WHEREAS, given the Court of Appeals' determination an exhaustion of appeals has occurred and thus the monies held in the District's TCRF are not reasonably required to pay a judgment or claims and shall revert to the District's General Fund;

NOW THEREFORE, the Board of Education hereby authorizes the reversion of \$1,300,000 from the District's TCRF to the District's General Fund in accordance with Education Law §3651.
