# TRANSFER FROM GENERAL FUND TO CAPITAL RESERVE FUND

MOTION

by Mr. Spears, seconded by Mr. McGlynn, WHEREAS, the Board of Education has since determined the discrete amount of funds available after the closure of the District's fiscal books for the 2013-2014 school year, the Superintendent recommends that the Board of Education authorize the transfer of \$1,843,239 from the existing 2013-2014 Fund Balance to the existing Capital Reserve Fund, which was approved by public referendum on May 20, 2008.

Note: The funding transfer related to additional revenues received from the State/County/Town/other, as well as budgetary appropriations that were not expended, is based upon the Board's understanding of the allowable use thereof.

# PAYMENT OF ESCO I BOND AND PLAYGROUND LEASE:

MOTION by Mr. Spears, seconded by Mrs. Watson,

WHEREAS, the Bethpage School District is currently making payments on an ESCO I bond and playground lease; and

WHEREAS, payments on the ESCO I bond are scheduled to continue through December, 2022 and payments on the playground lease financing is scheduled to occur through June, 2016; and

WHEREAS, after financial review the Board has determined that the District is currently able to make full payment of the ESCO I and playground lease and that making such payment as soon as possible would result in substantial cost savings to the District and would serve the best fiscal interests of the community; and

WHEREAS, pursuant to the requirements of the financing the first available time to make such payments without penalty is December, 2014.

NOW THEREFORE BE IT RESOLVED, that the Board of Education direct the Superintendent to take all necessary action to effectuate the full payment of the ESCO I and playground lease without penalty as soon as possible in the approximate total amount of \$1,805,268.12 (\$1,700,904.92 for the ESCO I) and (\$104,363.20 for the playground leave); and

BE IT FURTHER RESOLVED, that the Superintendent and Board President be authorized to complete, sign and submit any and all necessary documentation to effectuate such payment on the Board's behalf.

WHEREAS the District has reviewed the bid and by virtue of the District's polices and Section 103, the District may contract for elevator maintenance services through the Western Suffolk BOCES award to Barist Elevator;
