Regular Substitute (Leave Replacement)

MOTION by Mr. Dauman, seconded by Mrs. Israelton, that the Board of Education approve the Regular Substitute (Leave Replacement) appointment of Randi Bender in the area of School Social Worker for the remainder of the 2009-2010 school year, effective January 25, 2010. Salary will be \$61,394, based on Step 1 of the MA 2009-2010 salary schedule, to be prorated from date of commencement. Ms. Bender is provisionally certified as a school social worker in the State of New York.

Probationary Instructional

Salary will be \$63,310, based on Step 2 of the MA 2009-2010 salary schedule. Ms. Blask is initially certified to teach remedial reading in the State of New York.
