**Amendment to Agreement**

MOTION by Mr. Spears, seconded by Mr. McGlynn: WHEREAS, the Board of Education of the Bethpage Union Free School District and Terrence Clark entered into an agreement on January 27, 2009 (“January 27, 2009 Employment Agreement”) for Mr. Clark’s services as Superintendent of Schools; and

WHEREAS, the January 27, 2009 Employment Agreement provides for payment to the Superintendent for annual association memberships and professional publications and periodicals for each school year; now

BE IT HEREBY RESOLVED that the Board of Education of the Bethpage Union Free School District ratifies an April 20, 2010 Amendment to the January 27, 2009 Employment Agreement, which Amendment shall be effective July 1, 2009, *nunc pro tunc*, to provide that the annual payment for annual association memberships and professional publications and periodicals shall not exceed Two Thousand Four Hundred Dollars (\$2,400.00) and further authorizes the Board President to execute such Amendment on the Board’s behalf.

**2009-2010 BUDGET APPROPRIATION TRANSFER**

WHEREAS, the Board of Cooperative Educational Services of Nassau County (hereinafter “BOCES”) has proposed and presented its Proposed Administrative Operations Budget for the 2010-11 school year (July 1, 2010 through June 30, 2011), now therefore be it

RESOLVED, that the Nassau BOCES Proposed Administrative Operations budget for the 2010-2011 school year, in the amount of eighteen million four hundred twenty-eight thousand three hundred eighty-seven dollars (\$18,428,387) be, and hereby is APPROVED by this Board.
