**AWARD OF COOPERATIVE BID# 003-1112**

MOTION by Mrs. Israelton, seconded by Mr. Kelly, that the Superintendent recommends that the Board of Education of the Bethpage Union Free School District, acting as lead agency for the Nassau County Directors of School Facilities Purchasing Consortium in regard to Cooperative Bid #003-1112, accept the results of Cooperative Bid# 003-1112 for the 2011-2012 school year on behalf of the Consortium and award the contract to the lowest responsible bidder meeting specifications, which is Maintenance, Installation, Supply & Repair of Interior and Exterior Doors, Frames and Hardware. The Superintendent further recommends that the Board of Education authorize the Board President to execute, on its behalf, the contract with P & M Doors, pursuant to the terms in the bid package.

**AWARD OF 2009 CAPITAL TOILET RECONSTRUCTION BID, SED # 28-05-21-030-001-028**

**MOTION** by Mrs. Israelton, seconded by Mrs. Watson, that the Superintendent recommends that the Board of Education of the Bethpage Union Free School District accept the results of the 2009 Capital Reserve Toilet Reconstruction Bid, SED # 28-05-21-030-001-028, and award the contract to the lowest responsible bidder meeting specifications, which is ACL Construction Corp. The total cost to the District under the bid shall be \$283,000, inclusive of the alternate and which includes work at two worksites within the Bethpage High School. Also contained within the \$283,000 total cost are the costs of the subcontractors, which are \$56,000 to F.J.C. Plumbing and Heating and \$14,500 to Palace Electric Inc. The Superintendent further recommends that the Board of Education authorize the Board President to execute, on its behalf, the contract with ACL Construction Corp., pursuant to the terms of the bid package.
