# RESOLUTION OF THE BETHPAGE UNION FREE SCHOOL DISTRICT, NEW YORK (THE "DISTRICT")

by Mr. McGlynn, seconded by Mrs. Watson, ADOPTED NOVEMBER 27, 2012, AUTHORIZING THE REFINANCING OF THE DISTRICT'S MASTER LEASE PURCHASE AGREEMENT, DATED SEPTEMBER 28, 2006: DELEGATING CERTAIN POWERS TO THE PRESIDENT OF THE BOARD OF EDUCATION AND/OR THE ASSISTANT SUPERINTENDENT FOR BUSINESS IN CONNECTION THEREWITH: MAKING CERTAIN AND OTHER DETERMINATIONS RELATED THERETO.

#### Recitals

WHEREAS, on September 28, 2006, the Bethpage Union Free School District (the "District") entered into an Master Lease Purchase Agreement (the "2006 Lease Agreement") with Municipal Leasing Consultants, to finance, on a tax-exempt basis, certain energy conservation measures undertaken by the District pursuant to an energy performance contract entered into by the District and the installation of playground equipment and;

WHEREAS, the annual rate of interest for the 2006 Lease Agreement is 4.07% and the final maturity date is June 1, 2023; and WHEREAS, based upon the recommendation of Capital Markets Advisors, LLC ("CMA"), the District's financial advisor, the District now seeks to refinance said 2006 Lease Agreement and achieve certain annual savings to the District associated therewith; Now therefore,

THE BOARD OF EDUCATION OF THE BETHPAGE UNION FREE SCHOOL DISTRICT, NASSAU COUNTY, NEW YORK, HEREBY RESOLVES (by a majority vote of all the members of said Board) AS FOLLOWS:

Section 1. The Bethpage Union Free School District (the "District"), Nassau County, New York is hereby authorized to refinance the Master Lease Purchase Agreement, dated September 28, 2006 (the "2006 Lease Agreement"), with Chase Equipment Finance, Inc., with the proceeds of one or more lease agreements to be entered into by the District.

Section 2. The proposal of Sovereign Bank, N.A. is hereby accepted and the President of the Board of Education and/or the Assistant Superintendent for Business are hereby authorized to negotiate, approve, enter into, execute, and deliver any and all contracts, agreements, and other documents necessary or incidental to effectuate the refinancing and amendment of the 2006 Lease Agreement; and such contracts, agreements and other documents are hereby approved.

Section 3. The principal amount of any new lease agreement entered into to refinance the 2006 Lease Agreement shall not exceed

\$2,337,707.03or such additional amount as may be necessary to refinance the 2006 Lease Agreement; and the term of such new lease agreement shall not extend beyond June 1, 2023.

Section 4. The District's obligations under any new lease agreements entered into to refinance the 2006 Lease Agreement shall be subject to annual appropriation or renewal by the Board of Education of the District and the District's obligations under the such agreements shall not constitute a general obligation of the District or indebtedness under the Constitution or laws of the State of New York.

Section 5. The President of the Board of Education and/or the Assistant Superintendent for Business are hereby authorized to take any and all other actions necessary or desirable in connection with the refinancing of the 2006 Lease Agreement.

Section 6. This resolution shall take effect immediately
